

Florida Supercon 2023 XP SWEEPSTAKES – Florida Supercon 2023
(the “Sweepstakes”)
Official Sweepstakes Rules

1. HOW TO ENTER:

(a) Florida Supercon 2023 XP Sweepstakes Florida Supercon 2023 Entry. This Sweepstakes is being held in connection with Florida Supercon 2023 at the Miami Beach Convention Center, taking place from June 30th, 2023, through July 2nd, 2023 (the “Show”) The Sweepstakes begins at 10:00 AM EST on Friday, June 30th, 2023 and ends at 5:00PM EST on Sunday, July 2nd, 2023, (the “Sweepstakes Period”). During the Sweepstakes Period, eligible participants may enter the Sweepstakes by scanning their official event credential badge at any of the designated “Florida Supercon 2023 XP” badge scanner locations in the Miami Beach Convention Center. All entries must be received during the Sweepstakes Period. Eastern Standard Time shall control for all purposes of this Sweepstakes. Sponsor's clock shall be the official timekeeper for the Sweepstakes. The Sweepstakes is governed by these official rules and is subject to all applicable U.S. federal, state and local laws. This Sweepstakes is void where prohibited. By entering, each participant in this Sweepstakes assumes all risk incidental to participation in in the Sweepstakes.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

(c) Limit one entry per person, per Show badge. Multiple entries are not permitted. Entries by the same person in excess of the limits stated herein will be disqualified. In the event of a dispute over the identity of an entrant, an entry will be deemed submitted by the authorized account holder of the email address associated with the Show badge from which the entry was submitted at the time of entry. “Authorized account holder” is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider or organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted email address. One (1) grand prize winner will be awarded two (2) badges good for admission across all three days of Florida Supercon 2024 (or a comparable prize, depending on scheduling and availability) and (each, a “Prize” and, collectively, the “Prizes”) (the total estimated retail value of each Prize is **US\$250.00**). Prizes do not include any travel expenses, personal expenses, or any other costs not specifically described in

these Official Rules as included in the Prize and will be the responsibility of the winner and his/her guest(s). All expenses on receipt and use of Prizes are the sole responsibility of the winner. In the event that any of the Prizes or any part of the Prizes become unavailable, for any reason whatsoever, winner agrees that the Sponsor and its agents shall have no further obligations, other than to deliver the remainder of the Prize. If any winner, or winner's guest, are unable or unwilling to accept or participate in any part of the Prize, that portion of the Prize will be deemed as forfeited by such winner and no substitution will be made except at Sponsor's sole discretion. 3. WINNER SELECTION:

A total of one (1) winner will be selected by Sponsor in a random drawing occurring after 5:00PM EST on or **about Friday, July 14th, 2023**, from all eligible entries received in the Sweepstakes Period prior to the drawing date. The drawing will be conducted by Sponsor, whose decisions are final and binding on all matters relating to this Sweepstakes. Winners need not be present to win. Odds of winning are dependent upon the total number of eligible entries received. Sponsor will attempt to notify the potential winners by email by **Friday, July 21st, 2023**. The potential winners will have 48 hours from receipt of such notification to claim their Prize by emailing their full name and email address (and proof of eligibility if requested) as noted by Sponsor in the notification. After claiming the Prize, the potential winners will receive instructions on redeeming their Prize. Sponsor reserves the right, in its sole discretion, to not select a winner(s) if an insufficient number of eligible, complete, appropriate or generally qualified entries are received.

Each potential winner and their guest(s) may be required, in Sponsor's discretion, to execute and return an Affidavit of Eligibility, Release of Liability, and Publicity Release within ten (10) days of notification attempt or the Prize will be forfeited and an alternate winner selected. The Released Parties assume no responsibility for any injury or damage to entrants or to any other person's computer, regardless of how caused, relating to or resulting from entering or downloading materials or software in connection with this Sweepstakes.
